Confirmation of Registration

Immediately after having finalized and paid for your registration, an email acknowledgement and confirmation will be sent to the email address entered in the registered profile.

Shortly before the Congress, you will receive an email including updated information on the programme as well as your individual barcode letter. This email will allow you to access the Congress premises and Congress sessions, exhibition, and poster halls.

Payment Deadlines and Conditions

Credit Card

Credit card payment (in EUR only) is the preferred method of payment. The following credit cards are accepted as part of the online registration process: VISA and MasterCard®. Please note that your credit card will be charged directly at the moment of check out.

Bank Transfers

Any bank charges by local or intermediate bank must be borne by the remitter. Payment by bank transfer will not be accepted after 12 May 2023. After 12 May 2023, any outstanding amounts must be paid by credit card. Clearly indicate the name of the participant(s) and EACR 2023 registration number on the remittance slip/reference text when making a bank transfer.

If full payment is not received by the corresponding registration deadlines, the subsequent rate automatically applies. Please note that deadlines are at 23:59 CET on all published dates.

Participants must follow the cancellation process if they decide to withdraw. Unpaid amounts will remain due, even if the participant does not attend the Congress.

Paying the Correct Rates

Participants are expected to pay the correct registration rate that applies to them. If an incorrect registration rate is paid in error, we will require the correct rate to be paid in order to finalise your registration.

Member rates (EACR Member, EACR Early Career Member, and EACR Student Member) apply to those who are current members of the EACR, in the relevant category of membership, at the time of registration.

Industry rates apply to participants who work for a for-profit company and are funded to attend the meeting by that company. If they are a current EACR member, the member rate will apply.

Replacements and Cancellation Policies

All cancellations must be made in writing to the EACR 2023 Registration Team via email at eacr@newway-management.com.

Cancellation requests received within 14 days of purchase	Full refund
Cancellation requests received after 14 days of purchase but before 09 June 2023	Full refund minus an administrative charge of 50 EUR
Cancellation requests received after 09 June 2023 if a participant is unable to travel due to testing positive for COVID-19* or due to government travel restrictions within or imposed upon their country	Full refund minus an administrative charge of 50 EUR
Any other cancellation request received after 09 June 2023	No refund

* The organisers reserve the right to require proof of a positive COVID-19 test

All refunds will be processed after the Congress.

Replacements (= participant change) of a confirmed registration can be made and are subject to a 50 EUR administrative fee.

In the event of serious, special or unforeseen circumstances beyond EACR's control and other than Force Majeure, the organiser shall be entitled to cancel the Congress. Registered participants shall not be entitled to seek compensation for any costs or damages incurred other than the registration fees paid to the EACR which will be reimbursed to the registrant.

We strongly advise all participants to obtain appropriate insurance to cover travel, accommodation and any other costs that may be incurred as a result of cancellation or postponement of the Congress.

COVID-19

The EACR and associated Congress organisers will do everything we can to make the event safe. We will comply with any local and international restrictions in place at the time and we reserve the right to introduce checks for proof of vaccination/negative test at any point before the Congress.

- If you are unable to attend the Congress because of unavoidable government travel restrictions (such as a 'lockdown', or restrictions on travel from your country) introduced after you have registered, you will be entitled to a full refund of your registration fee minus an administrative charge of 50 EUR.
- If you are unable to attend the Congress because you have tested positive for COVID-19, you will be entitled to a full refund of your registration fee minus an administrative charge of 50 EUR. The organisers reserve the right to require proof of a positive COVID-19 test.
- If the Congress is cancelled due to a pandemic, we will refund all registration fees.
- If the Congress is postponed due to a pandemic, we will refund your registration fee if you are unable to attend on the new dates.

Letter of Invitation/ Visa Letter

Personal data
